Kelly are the managers of ASAC II LLC. Mr. Kotick disclaims beneficial ownership of the Company's common stock held by ASAC II LP except to the extent of his pecuniary interest therein.
- Mr. Kotick directly holds (a) 1,133,550 restricted stock units, each representing the right to receive a share of the Company's common stock, (b) 3,313,246 performance shares, each representing the right to receive a share of the Company's common stock, and (c) 979,731 shares of the Company's common stock.
